Chapter 1 Introduction

1.1 Intended Uses

1.1.1 Selenia Dimensions System Intended Use

The Hologic[®] Selenia[®] Dimensions[®] system generates digital mammographic images that can be used for screening and diagnosis of breast cancer. The Selenia Dimensions (2D or 3D) system is intended for use in the same clinical applications as a 2D mammography system for screening mammograms. Specifically, the Selenia Dimensions system can be used to generate 2D digital mammograms and 3D mammograms. Each screening examination may consist of:

- a 2D FFDM image set; or
- a 2D and 3D image set, where the 2D image can be either an FFDM or a 2D image generated from the 3D image set and the 3D image set can be viewed as either 1-mm 3D slices or 6-mm 3D SmartSlices.

The Selenia Dimensions system may also be used for additional diagnostic workup of the breast.



Note

In Canada and Singapore, Tomosynthesis is not approved for screening and must be used in conjunction with a 2D image (either a FFDM image or 2D image generated from the 3D image set).

Contrast Enhanced Digital Mammography

Contrast Enhanced Digital Mammography (CEDM) is an extension of the existing indication for diagnostic mammography with the Selenia Dimensions system. The CEDM application shall enable contrast enhanced breast imaging using a dual energy technique. This imaging technique can be used as an adjunct following mammography and/or ultrasound exams to localize a known or suspected lesion.

1.1.2 Genius Al Detection Software Intended Use

Genius AI® Detection software is a computer-aided detection and diagnosis (CADe/CADx) software device intended to be used with compatible digital breast tomosynthesis (DBT) systems to identify and mark regions of interest including soft tissue densities (masses, architectural distortions, and asymmetries) and calcifications while reading DBT exams from compatible DBT systems and provide confidence scores that offer assessment for Certainty of Findings and a Case Score. The device intends to aid in the interpretation of digital breast tomosynthesis exams in a concurrent fashion, where the interpreting physician confirms or dismisses the findings during the reading of the exam.

1.1.3 Contraindications

There are no known contraindications.

1.3 Intended User

Qualified technically trained personnel position the patient and operate the device (such as a mammography technologist), calibrate the device (such as a medical physicist), and interpret the image produced by the device (such as a radiologist).

1.4 Patient Target Group

Asymptomatic patients who are at average risk or at higher than average risk for breast cancer require breast cancer screening imaging. Those patients who may have symptoms related to breast cancer or abnormal findings on a screening exam also need diagnostic imaging using the same or similar modalities. Qualified medically-trained personnel will decide based on shared decision making with the patient and, in some cases, the provider whether a radiographic examination is indicated based on patient age, patient health, and physical condition.

1.5 Clinical Benefits

Population based mammography screening is the best method for detecting breast cancer before symptoms occur and is the only modality that has been proven to reduce mortality.

1.6 Potential Adverse Effects of Mammography Systems on Health

Following is a list of the potential adverse effects (such as complications) associated with the use of the device (these risks are the same as for other screen-film or digital mammography systems):

- Excessive breast compression
- Excessive x-ray exposure
- Electric shock
- Infection
- Skin irritation, abrasions, or puncture wounds

1.7 System Capabilities

The system provides the user interfaces for the performance of screening and diagnostic mammograms:

- Conventional mammography with a digital image receptor equivalent in size to large mammography film.
- Tomosynthesis scan with a digital image receptor equivalent in size to large mammography film (Tomosynthesis option).
- Conventional digital mammogram and tomosynthesis scan during one compression (Tomosynthesis option).

The Genius[®] 3D MammographyTM exam (also known as Genius[®] exam) is acquired on a Hologic[®] 3D MammographyTM system and has a 2D and a 3DTM image set. The 2D image can be either an acquired 2D image or a 2D image generated from the 3DTM image set. The Genius[®] exam is only available on a Hologic[®] 3D MammographyTM system.

Genius[®] 3D MammographyTM is the brand name of a Hologic[®] 3D MammographyTM exam and may not be available in all markets.

The C-View and Intelligent 2D software is an image processing application for postprocessing the pixel data from tomosynthesis data, captured on a Hologic tomosynthesis imaging system, into a digital mammography (2D) image. The C-View or Intelligent 2D synthesized 2D image can be used in place of a digital mammogram (2D) as part of a screening study employing tomosynthesis.

The C-View and Intelligent 2D software processes tomosynthesis data to generate 2D images which are designed to appear similar to and serve the same purpose as a digital mammogram (2D) when used as part of a screening study employing tomosynthesis.

Configuration

The C-View and Intelligent 2D software has no user-configurable settings that influence the appearance of the resulting synthesized 2D images. C-View and Intelligent 2D images are produced in either DICOM Breast Tomosynthesis Image format, as a single thick slice, or DICOM Digital Mammography X-Ray Image format. The site PACS administrator, in consultation with Hologic connectivity engineers, can select the output format most appropriate for the site's IT infrastructure and workstations. Each C-View or Intelligent 2D image DICOM header contains the information needed to differentiate it from any accompanying conventional 2D image(s) or tomosynthesis image sets in the same view. An annotation ("C-View" or "Intelligent 2D") is also burned to the synthesized 2D image pixel data.

Workflow

As with any imaging study, the technologist selects the patient and identifies the type of imaging procedure that will be done. For an exam with C-View or Intelligent 2D images, the process of imaging the subject and completing the study is all that is necessary. The C-View and Intelligent 2D software itself operates with no direct human intervention.

1.11 About 3DQuorum Software



Note

3DQuorum[®] imaging technology may not be available in all regions. Contact your sales representative for information.

3DQuorum[®] software uses image data available from a high-resolution breast tomosynthesis acquisition to generate SmartSlices, which are "slabbed" 3D images. The SmartSlices are created without the need for an additional digital tomosynthesis exposure. A SmartSlice can be perceived as a "thick" version of a tomosynthesis slice and is equivalent to six slices (6 mm) from the original tomosynthesis reconstruction. The SmartSlice volume consists of sequentially synthesized slices. Each SmartSlice shares half of its contents with the SmartSlice before and the other half with the SmartSlice after. Therefore, when reviewing SmartSlices, the images are advanced three 1-mm tomosynthesis slices at a time. The resulting number of images to be reviewed by a radiologist in a study is one-third the number of a tomosynthesis 1-mm reconstruction image set.

SmartSlices are designed to reduce the total tomosynthesis screening study interpretation time by decreasing the total number of images a radiologist is required to review. SmartSlices images are not intended to be used without the synthesized 2D images to make a clinical decision or diagnosis.

1.11.1 Warnings for 3DQuorum Software

Warning:

Do not make a clinical decision or diagnosis from the SmartSlice images without reviewing the accompanying synthesized 2D image set.

Use SmartSlices in the same way you would use the 3D 1-mm slices (or tomosynthesis reconstructed slices) when reviewing a tomosynthesis screening study. 1.11.2 Theory of Operation for 3DQuorum Software

Overview

3DQuorum software is an image processing application for post-processing a limited number of slices of tomosynthesis data, captured on a Hologic tomosynthesis imaging system, into a combined 3D image. The SmartSlices image set reduces the number of images to one-third compared to tomosynthesis reconstructed slices data set while maintaining clinical information. As a result, read times for the radiologist can be reduced by about 13%. And for archival and transmission purposes, file sizes can be reduced by over 50%. SmartSlices can be used in place of the tomosynthesis reconstructed slices when reviewing a screening study employing tomosynthesis. SmartSlices achieve the same sensitivity as reading 1-mm 3DTM slices.

Configuration

3DQuorum software has no user-configurable settings that influence the appearance of the resulting SmartSlices. SmartSlices are stored and transmitted as a series of frames using the DICOM Breast Tomosynthesis Image object format. The DICOM header for SmartSlices contains the information needed to differentiate it from any accompanying tomosynthesis reconstructed slices in the same view. An annotation ("3DQuorum") is also burned into the SmartSlices pixel data.

During the initial installation of 3DQuorum software, the system is configured to allow sending of tomosynthesis reconstructed slices and SmartSlices to PACS and diagnostic workstations. The default output groups can be configured to send only SmartSlices, only tomosynthesis reconstructed slices, or both to the preferred devices automatically. The site PACS administrator, in consultation with Hologic connectivity engineers, can select the output formats most appropriate for the site's IT infrastructure and workstations.

As with the introduction of any new imaging technology, Hologic advises testing SmartSlices with your PACS, workstations, and other Imaging Enterprise devices to ensure compatibility.

Workflow

For tomosynthesis screening exams with 3DQuorum software, the process of imaging the subject and completing the study is all that is necessary. The 3DQuorum software itself operates with no direct human intervention.

1.12 About Genius Al Detection Software

Genius AI Detection® software is a software module intended to identify suspicious breast lesions appearing as soft-tissue densities (masses, architectural distortions, and asymmetries) or calcification clusters in breast tomosynthesis images. Genius AI Detection software analyzes the tomosynthesis data set for each view from a Hologic 3D MammographyTM exam to identify such lesions using deep learning neural networks. For each identified lesion, Genius AI Detection software produces the following CAD findings:

- Slice where the lesion is best represented.
- Location of the lesion.
- Outline of the lesion.
- Confidence score of the lesion.
- Correlated findings for the lesion (if applicable).

In addition, Genius AI Detection software produces a case score for the entire breast tomosynthesis exam representing the confidence that the exam contains a malignant lesion.

Genius AI Detection software stores all properties of these CAD findings into a DICOM Mammography CAD SR object for storage and display on DICOM-compliant review workstations and archive systems. An option to create a DICOM Secondary Capture Image is available when the review workstations cannot interpret DICOM Mammography CAD SR objects.




Figure 1: Tubestand for Selenia® Dimensions® System





Figure 2: C-arm Overview

2.4 Emergency Off Switches

The Emergency Off switches remove the power from the Gantry and the Acquisition Workstation Lift Mechanism (on the workstations that include that option). Do not routinely use the Emergency Off switches to turn off the system.




Figure 4: Emergency Off Switch Functionality

There are three Emergency Off switches, one on each side of the Gantry and one on the Acquisition Workstation.

- To turn Off the Gantry and disable the Acquisition Workstation Lift Mechanism, press any of the Emergency Off switches.
- 2. To reset the Emergency Off switch, turn clockwise approximately one-quarter turn until the switch pops back out.

2.5 Interlocks

The system has safety interlocks:

- C-arm vertical movement and rotation are disabled when compression force is applied. A Service Engineer can configure the lockout force from 22 Newtons (5 pounds) to 45 Newtons (10 pounds).
- If the x-ray button and/or x-ray footswitch* is released before the end of the exposure, the exposure stops and an alarm message is displayed.

* (The x-ray footswitch option is available only on the Universal Acquisition Workstation console.)

- When in Tomo mode, the system does not allow an exposure if the Grid is in the x-ray field (Tomosynthesis option).
- Mirror and Filter position flags also prevent x-rays when the Light Field Mirror or the Filter Assembly is not correctly positioned.




Figure 6: Location of the System Label for the Universal Acquisition Workstation




Figure 8: Location of the System Label for the Standard Acquisition Workstation





Figure 9: System Power Controls




Figure 11: Tubehead Display




Figure 12: Compression Device




Figure 14: C-arm Control Panel







Figure 16: Universal Acquisition Workstation Controls and Displays Figure Legend






Figure 20: Universal Acquisition Workstation Power Buttons




Figure 21: Premium Acquisition Workstation Power Buttons




Figure 22: Standard Acquisition Workstation Power Buttons




Figure 23: Windows 10 Login Screen






Figure 27: Emergency Off Switch Functionality




Figure 28: Universal Acquisition Workstation Power Buttons




Figure 29: Premium Acquisition Workstation Power Buttons




Figure 30: Standard Acquisition Workstation Power Buttons




Figure 36: Split Patient Records Screen






Figure 40: Paddle Shift Buttons




Figure 44: Add View Screen




Figure 45: Edit View Screen


The *Edit View* screen for biopsy procedures shows different View Modifiers. Refer to the Affirm[®] breast biopsy guidance system *User Guide*.

5.4.7 Retrieve

Select the **Retrieve** button to query the configured devices with the current patient information. The **Retrieve** button performs the same function as the **Query Retrieve** button in the *Admin* screen.

5.4.8 Close a Patient

Select the **Close Patient** button. If images were acquired, the *Close Procedure* dialog box opens. Select one of the following options:



If there are images marked as Pend, a dialog box opens with the following options:

- Accept All and Close Complete
- Close Procedure In Progress
- Return to Procedure

If MPPS is activated, procedure status information is sent to the output devices when you select **Complete** or **Discontinue**. You can also select and hold the tab above the thumbnail images to resend a message about the procedure status during the procedure. A *Procedure Action* dialog box opens with buttons to resend a status or to return to the procedure.



Important

When you are licensed for 3DQuorum software, follow the standard procedure to close a patient. If there are SmartSlices that have not completed processing, a dialog box opens with the following message:

When you are licensed for Genius AI Detection software, ImageChecker CAD, or Quantra software, image analytics are run automatically when you select the **Close Procedure Complete** button after acquiring new images. The results are automatically sent to the Output Devices. When you reopen the patient, thumbnail images for the results are displayed in the *Procedure* screen and status tabs are available in the *Procedure Info* dialog box.

5.5 How to Access the Image Review Features

Select the **Tools** tab on the *Procedure* screen to access the image review features. Refer to *Image Review Tools Tab* on page 101 for information.

5.6 Output Groups

The accepted images are sent automatically to the output devices in the selected Output Group. The system configuration controls if the images are sent after a patient is closed or immediately after each image is accepted.



Note

Tomosynthesis images are not sent to a print device in the selected Output Group. You can print selected tomosynthesis slices and SmartSlices from the *Print* screen.

5.6.1 Select an Output Group




Figure 46: Output Groups Field

5.6.4 Custom Output

The Custom Output Group option lets you make an output group from the *Procedure* screen. The custom output group that you make stays as the Custom option until another custom output group is made.

To make a Custom Output Group from the *Procedure* screen:

- 2. In the *Output Group* dialog box, select from the list of available devices, then select **OK**.

5.7 On-Demand Outputs

The On-Demand Outputs are **Archive/Export** or **Print**. You can manually Archive, Export, or Print the currently opened patient until the procedure is closed.

When you select an **On-Demand Output** button, you have the option to send images from the patient that is open to any of the configured output devices.

5.7.1 Archive

- 1. Select the Archive/Export button.
- 2. Select the procedure or views in the *On Demand Archive* screen:
 - Select All button selects all items that show in this screen.
 - Clear button deselects items that are selected in this screen.
 - Priors button shows previous procedures and views for this patient.
 - **Rejected** button shows rejected views for this patient.
- 3. Select a storage device:
 - Select the **Device List** button and make your selection from the options in the *Storage Device* drop-down menu.

- Select an output group from the *Output Group* drop-down list.
- 4. Select the **Archive** button to send the selected images to the selected archive.




Figure 51: Print Screen

Chapter 6 Imaging

6.1 Image Display Screen

After you make an exposure, the acquired image opens on the Image Display monitor. Patient and procedure information can be displayed on the screen. To turn the information on or off, go to the **Tools** tab in the *Procedure* screen and select the **Patient Information** button.




Figure 52: Image Display Screen (SmartSlices option shown)

6.2 How to Set the Exposure Parameters

6.2.1 Select the Image Acquisition Mode (Tomosynthesis Option)

- Standard For routine Tomosynthesis screening procedures
- Enhanced For diagnostic Tomosynthesis views



Warning:

Enhanced acquisition mode with combo mode imaging (DM + BT) can produce radiation dose that is higher than the MQSA screening limit of 3.0 mGy and therefore should only be used in diagnostic evaluation.

6.2.2 Select the Exposure Mode

Use the Automatic Exposure Control modes (AEC) to let the system control the exposure techniques. AEC modes are available from 20-49 kV.

- Manual The user selects the kV, mAs, Focal Spot, and Filter.
- AEC: Auto-Time The user selects the kV, Focal Spot, and Filter. The system selects the mAs.
- AEC: Auto-kV The user selects the Focal Spot. The system selects the kV, mAs, and Filter (Rhodium).
- AEC: Auto-Filter The user selects the Focal Spot. The system selects the kV, mAs, and Filter.

6.2.3 How to Use the AEC Sensor

The AEC Sensor has seven manual positions and an automatic position. The manual positions start at the chest wall edge (position 1) and reach toward the nipple edge (position 7). The automatic position selects two regions within an area that extends from the chest wall to the nipple.

Use the plus (+) and minus (-) keys on the Compression Device or in the AEC Sensor area of the screen to change the sensor position. You can select Auto AEC to allow the system to calculate the best exposure for the breast.

6.3 How to Acquire an Image

Refer to <u>Clinical Procedures</u> on page 131 for information about clinical procedures.

- 1. Select a view from the thumbnail views at the bottom of the *Procedure* screen.
- 2. Press and hold the **x-ray** button and/or the **x-ray footswitch** for the full exposure. During the exposure:
 - The System Status bar shows the radiation symbol and a yellow background (see the following figure).




Figure 53: Exposure In Progress

• An audible tone continues to sound during the exposure.

The audible tone is a continuous sequence of tones. The tone sounds during the entire combo acquisition from the initiation of the exposure to the end of the conventional view. There is no interruption of the audible tone between breast tomosynthesis and conventional digital mammography exposures. Do not release the exposure switch during the audible tone.

3. When the tone stops and the System Status bar shows **Standby** (see the following figure), release the **x-ray** button and/or the **x-ray footswitch**.

4. When the x-ray is finished, the image appears on the Image Display monitor. The *Procedure* screen automatically changes to the **Tools** tab.

Select one of the following options to complete the acquisition:

- Accept the image. The image transmits to output devices with all attributes.
- **Reject** the image. When the dialog box opens, select the reason for rejecting the image. The *Image Display* screen closes. You can repeat the rejected view or select another view. If you select **Reject**, an "X" appears on the thumbnail image.
- **Pend** the image. The image saves for future review. If you select **Pend**, a question mark "?" appears on the thumbnail image.

6.3.1 Conventional Imaging Sequence of Events

- 2. Accept, Reject, or Pend the image. A thumbnail image replaces the thumbnail view in the Case Study area of the screen.

A Manager user can configure the system to Auto-Accept or Auto-Pend new images.

6.3.2 Tomosynthesis Imaging Sequence of Events

- 1. Wait for the image reconstruction to complete.
- 2. Review the projection images for motion.
- 3. Accept, Reject, or Pend the images. A thumbnail image replaces the thumbnail view in the Case Study area of the screen.



Note

A Manager user can configure the system to Auto-Accept or Auto-Pend new images.

6.3.3 How to Accept a Rejected Image

If a rejected image is better than the new image, you can retrieve and use the old image. Select the thumbnail image on the *Procedure* screen to review the image, then **Accept** the image.

6.3.4 How to Accept or Reject a Pended Image

To accept or reject a Pended image, select the Pended thumbnail image, then select the **Accept** button or the **Reject** button.





- 3. Use the + and buttons to move the AEC sensor to the tissue behind the nipple.



- 4. Acquire the exposure.
- 5. Accept, Reject, or Pend the images.

6. Repeat steps 1 through 5 for each view.

6.4.2 Implant Near the Nipple

- 1. Select a view from the thumbnail views at the bottom of the *Procedure* screen.

- Use the + and buttons to select the kVp and mAs values. Refer to the tables in <u>Values</u> <u>Tables for Implant Near the Nipple</u> on page 96 for the recommended values based on the type of view and the compression thickness.





Select the **Implant Present** button on the *Procedure* screen to indicate an implant exists. A check mark appears on the button and the image reprocesses.



6.5.2 If the Image Is Accepted

- 1. Select the image.
- 2. Select the **Implant Present** button on the *Procedure* screen to correct the image. A check mark appears on the button and the image reprocesses.
- 3. Select the **Accept** button to accept the changes.




Figure 58: Tools Tab (Tomosynthesis option shown)




Figure 59: Image Review Tools

- 5. The **Window/Level** tool changes the brightness and contrast.
- 6. The **Window/Level Fine Adjustment** tool allows the entry of specific window and level values.
- The LUT Selection tool scrolls through available Window/Level settings for a displayed image with LUTs attached.
- 8. The **AEC** button displays the AEC Sensor areas used for the exposure calculation. The sensor areas display on the *Image Display* screen.
- 9. The Patient Information button activates the patient information display.
- 10. The **Auto-Hanging** button automatically hangs the currently selected study in a 4-up configuration.
- 11. The **Auto-Pairing** button turns off auto-pairing for the currently selected image in a multi-up configuration.
- 12. The **SNR/CNR** button calculates the signal-to-noise ratio and contrast-to-noise ratio on the ACR Phantom.
- 13. The **Fit-to-Viewport** button fits the image within the image tile.
- 14. The **True Size** button displays the image in the actual size of the breast.
- 15. The View Actual Pixels button displays the image in full resolution.
- 16. The **Multi-Up Display** button selects the number of tiles to display.
- 17. The Image Tile Advance button sets the active Multi-Up tile.
- 18. The Invert Image tool changes blacks to whites and whites to black.
- 19. The Mirror button reverses (mirrors) the image.
- 20. The **Tag for Print** button tags the projection or reconstruction images of a tomosynthesis image to print later.

6.6.2 Notices Tab

The tools on the **Notices** tab allow you to mark and annotate images and send notices about the displayed image or procedure. The **Notice Output Groups** drop-down menu at the bottom of the tab allows you to select the destination for the Notices.




Figure 60: Tools on the Notices Tab

Exposure Index

The Exposure Index is an image quality guide. When the Exposure Index indicates the red or yellow area, review the selected image for noise and decide whether to reacquire the image.




Figure 62: Display Modes




Figure 63: Projection Indicator




Figure 64: Slice Indicator (*SmartSlices option shown*)

- 5. Select the low energy and subtraction buttons to display both low energy and dualenergy subtracted images.
 - Low Energy: Conventional low-energy image
 - Subtraction: Contrasted, subtracted image
 - Show Low Energy and Subtraction images in 2-up display: Shows both the low and sub screen images side-by-side in a split screen.



Caution:

Performing an I-View 2D Contrast procedure increases the recovery time the machine needs before more images are acquired. When the System Status icon appears red

(), a recommended wait time is shown. This wait time lets the x-ray tube temperature decrease to avoid damage that can void the x-ray tube warranty. If the System Status icon turns red during a procedure, follow the guidance provided in section <u>Tube Loading Indicator</u> on page 108.

The x-ray tube heat load is tracked by the tube loading indicator. Be aware of the tube loading status when acquiring Contrast Enhanced images. Refer to <u>*Tube Loading Indicator*</u> on page 108 for more information.

6.8.1 Tube Loading Indicator

The **Generator** tab of the *Procedure* screen includes a Tube Loading indicator. This indicator shows the current heat load of the X-ray tube.

The Tube Loading indicator displays one of the following three statuses:

• A green status means that the heat loading of the x-ray tube is below what is considered steady state heat loading. During the green status, the system can accommodate 4 patients per hour of I-View contrast enhanced procedures.






Note

Steady state heat loading of the Dimensions x-ray tube is defined as operating at 55% of x-ray tube heat capacity continuously. Steady state represents continuous Combo imaging at 8 patients per hour.

• The yellow status means that the x-ray tube heat loading is above what is considered steady state operation (see note above). Under yellow status, the system still has plenty of heat capacity to accommodate a full I-View contrast enhanced procedure and sustain such acquisitions for up to 4 patients per hour.





Note

The number displayed at the corner of the Tube Loading indicator shows the estimated tube heat loading with 55% representing steady state. It is expected that the Tube Loading indicator will turn yellow during an I-View contrast enhanced procedure and will remain yellow for the duration of the procedure. It is also possible, but rare, that the Tube Loading indicator appears yellow when opening a patient to start an I-View contrast enhanced procedure. In either case, the I-View procedure can continue uninterrupted. While the Tube Loading indicator remains yellow, the tube heat loading is considered safe.



Note

During a yellow Tube Loading status, the System Status icon may flash red with a number representing the number of minutes it will take to drop below the steady state heat loading. There is no need to wait before acquiring images under a yellow Tube Loading indicator despite the flashing System Status icon. The System Status icon is only informational and does not require action under a yellow Tube loading indicator.

• The red status means that the x-ray tube heat loading just passed a threshold, which is considered potentially risky when attempting to acquire additional images. Under red status, the system still has some heat capacity left (threshold is set to 75% of tube heat loading capacity). However, waiting is recommended for the suggested number of minutes indicated under the Tube Loading indicator prior to acquiring an additional image. Typically, this time is very short (approximately one minute). As soon as the Tube Loading indicator returns to yellow status, an additional image can be acquired.





Note

Under certain circumstances (for example, large compressed breast thickness or more than four contrast views), it is normal to see the Tube Loading indicator turn red after the last exposure of an I-View contrast enhanced procedure. The system will quickly come back to equilibrium, and it will return to yellow or even green status within minutes. Even if the Tube Loading indicator turns red occasionally, the system can still maintain a rate of 4 patients per hour undergoing I-View contrast enhanced exams. There is still space for additional heat loading to the x-ray tube.



Caution

Excessive heat buildup can damage the X-ray tube.

6.8.2 How to Configure the Contrast Settings

1. From the **Contrast** tab, select the **Configure Contrast** button to edit the contrast settings. The *Contrast Information* dialog box opens.




Figure 70: Specimen Imaging Screen

Chapter 7 Accessories

The system can perform screening or diagnostic applications with specified accessories. This chapter describes how to use all possible system accessories.



Note

Hologic configures some systems to meet specific requirements. Your system configuration may not have all the options and accessories included in this manual.

7.1 How to Install Accessories on the C-Arm

The Retractable Face Shield, Magnification Stand, and Localization Crosshairs are installed in slots on the C-arm. The slots have labels with icons to indicate the accessory that attaches in the slot. Each accessory has two lines. Align the accessory with the related line on the C-arm. When the hook on the accessory is at the correct depth, the second, thinner line aligns with the line on the C-arm. The next sections contain installation instructions for each accessory.




Figure 71: C-arm Accessories

- 1. Slot for Retractable Face Shield (Tomosynthesis option) or the Affirm® breast biopsy guidance system (biopsy option)
- 2. Slot for 1.8x Mag Stand and Localization Crosshairs
- 3. Slot for 1.5x Mag Stand

7.2 Patient Face Shields

The Face Shield keeps the head and face of the patient away from the x-ray field during the examination. Inspect the shield each day before use.



Warning:

The Face Shield must be attached for all exposures except magnification case studies.



Warning:

Ensure that the Face Shield is fully engaged on the C-arm. Incorrect installation of the Face Shield can result in injury to the patient and the user.



Warning:

The Face Shield does not protect the patient from radiation.

7.2.1 How to Install and Remove the Retractable Face Shield

To install the Retractable Face Shield:

- 1. Completely extend the Face Shield to the outer position.
- 2. Align the hooks of the Face Shield with the mounting slots on the C-arm, indicated by a face shield icon.
- 3. Put the hooks on both sides of the Face Shield into the mounting slots on the C-arm. The Unlock Lever (see item 1 in the following figure) is in the Up position.
- 4. Push the Face Shield to the down and locked position. The Unlock Lever is in the Down position when the Face Shield locks.




Figure 72: Align the Retractable Face Shield on the C-arm

To remove the Retractable Face Shield:

- 1. Press and hold the Unlock Lever (see item 1 in the previous figure) in the Up position.
- 2. Lift the Face Shield from the slots and remove from the C-arm.

7.2.2 How to Use the Retractable Face Shield



Note

Before you make an exposure, make sure the Face Shield is completely extended or completely retracted.

To extend the Face Shield, pull the Face Shield away from the C-arm until the device latches in the outer position.

To retract the Face Shield:

- 1. Press a Latch Release (see item 2 in the following figure one on each side).
- 2. Push the Face Shield toward the C-arm until the device stops.





Figure 73: Face Shield Installation

- 1. Pull the sides of the Face Shield in a horizontal direction (away from the tubehead).
- 2. Remove the Face Shield.



7.3.1 **Routine Screening Paddles**





The SmartCurve system paddles may not be suitable for all patients. If the breast cannot be properly immobilized or compressed due to the curvature of the paddles, use the standard flat screening paddles.



Note

The SmartCurve system paddles are not recommended for cleavage views, rolled views, or mosaic views of very large breasts. Use the standard flat screening paddles for these views.



Note

The SmartCurve system paddles accommodate most breast sizes. Due to the curvature of the paddles, some patients who would use the smaller standard flat paddle may be more easily positioned using the larger SmartCurve paddle.



Note

SmartCurve system paddles are not compatible with FAST Compression mode.







7.3.6 How to Install and Remove a Compression Paddle

To install a Compression Paddle:

- 1. Hold the front of the paddle with one hand in front of the Compression Device.
- 2. Tilt the paddle (between 30 and 45 degrees), then put the rear of the paddle on the groove in the rear of the Compression Device (item 1 in the following figure).
- 3. Slide the paddle along the groove until the slots on the top of the paddle are under the locks on the Paddle Clamp (item 2 in the following figure).
- 4. Compress the Paddle Clamp (item 3 in the following figure) with your free hand.
- 5. Rotate the paddle up (item 4 in the following figure).
- 6. Release the Paddle Clamp to lock the paddle.




Figure 76: Installation of a Compression Paddle

To remove a Compression Paddle:

- 1. Hold the paddle with one hand while you use the free hand to compress the Paddle Clamp to release the lock (item 1 in the following figure).
- 2. Lower the paddle (item 2 in the following figure) and remove the paddle from the Compression Device (item 3 in the following figure).
- 3. Release the Paddle Clamp.




Figure 77: How to Remove a Compression Paddle

7.3.7 Paddle Maintenance and Cleaning

Clean the paddles after each use. Refer to <u>Maintenance and Cleaning</u> on page 137 for cleaning instructions.

7.3.8 Paddle Shift

The system allows most paddles to move to the left or right of the center position. The feature helps small-breast examinations with lateral views. When a lateral view is selected, the system automatically moves the collimator for the selected paddle position.



Note

The 24 x 29 cm frameless screening paddle, the 24 x 29 cm SmartCurve system paddle, and the magnification paddles are NOT compatible with the paddle shift function.

7.3.9 FAST Compression Mode

About FAST Compression Mode

The Fully Automatic Self-adjusting Tilt (FAST) Compression Mode is for use when the composition of the breast tissue does not allow uniform compression across the complete breast with a flat compression paddle. For these patients, not enough compression can cause an image to appear to be out of focus at the anterior region from both involuntary motion and not enough compression.

The FAST Compression mode used with this type of breast provides these features:

- Reduced motion artifacts, because the compression is more effective
- More uniform compression, from the chest wall to the nipple
- Maximum patient comfort, because over compression at the chest wall is prevented

When the FAST Compression mode is selected, the paddle automatically tilts when compression is applied. The paddle starts at the flat position until some compression force is applied. The paddle then tilts until its maximum angle is reached.

The FAST Compression mode does not require excessive compression, but you must use enough compression to prevent the movement of the breast. You should use a consistent amount of compression, especially for related left and right views.

The FAST Compression mode may not be best for breasts that are equal or symmetrical in thickness from the chest wall to the anterior area of the breast.



Note

Only the 18 x 24 cm Frameless Screening Paddle and the 24 x 29 cm Frameless Screening Paddle are compatible with FAST Compression Mode.



Note

The system beeps when FAST Compression Mode is engaged but is not compatible with the current paddle.

How to Use the FAST Compression Mode Slide

To engage FAST Compression Mode, push the slide (from either side) until the "F" is visible and the slide clicks into position.




Figure 78: The FAST Compression Mode Slide

7.4 Magnification Stand

The Magnification Stand has a breast platform and an abdominal shield. When the Magnification Stand is installed, the grid automatically retracts and the x-ray exposure techniques are set to the Magnification default values. Only use the Magnification paddles when the Magnification Stand is installed (refer to <u>Magnification Paddles</u> on page 119).

7.4.1 How to Install and Remove the Magnification Stand




Figure 79: Installation of the Magnification Stand

To Install the Magnification Stand

- 1. Remove the Face Shield (refer to *Patient Face Shields* on page 114).
- 2. Remove the compression paddle (refer to *How to Install and Remove a Compression Paddle* on page 121).
- 3. Move the Compression Device completely to the top.
- 4. Hold the stand on each side just below the black buttons (see item 4 in the previous figure). Do not press the black buttons.



Note

The black buttons are used only when removing the Magnification Stand.



Note

There are two sets of mounting slots for the Magnification Stand—One set is for 1.8x, and the other set is for 1.5x. Refer to <u>How to Install Accessories on the C-Arm</u> on page 113 for more information.

- 5. Align the thick black lines on the Magnification Stand with the thick black lines on the C-arm. When these lines meet, the hooks of the Magnification Stand align to the mounting slots on the C-arm. See item 1 in the previous figure.
- 6. Put the hooks of the Magnification Stand into the C-arm slots. Slide the Magnification Stand down until the thin black lines on the Magnification Stand and the black line of the C-arm meet. See item 2 in the previous figure.
- 7. The locking pins slide into holes and lock the device. You hear an audible click.



Note

If the Magnification Stand is not installed correctly, there is an indicator with a red shaft which protrudes (see item 3 in the previous figure). When the stand is installed correctly, the indicator is retracted.

To Remove the Magnification Stand

- 1. Remove the Magnification paddle.
- 2. Hold the handles of the Magnification Stand and press the black buttons.
- 3. Lift and remove the device from the C-arm.

7.5 Crosshair Devices

7.5.1 How to Install and Remove the Localization Crosshair Device




Figure 80: Installation of the Localization Crosshair Device

To Install the Localization Crosshair Device:

- 1. Remove the face shield (refer to *Patient Face Shields* on page 114).
- Move the Compression Device below the mounting slots, indicated by a crosshair icon. Refer to <u>How to Install Accessories on the C-Arm</u> on page 113 for more information.
- 3. Hold the crosshair device by the handles and align the thick lines on the device with the line on the C-arm. Compress the release levers.
- 4. Put the hooks into the C-arm slots.
- 5. Slide the hooks toward the bottom until the thin black lines on the crosshair meet the black line on the C-arm.
- 6. Release the levers. The locking pins slide into holes and lock the device in position.

To Remove the Localization Crosshair Device:

- 1. Compress the release levers.
- 2. Lift the frame toward the top and remove the hooks from the C-arm slots.

7.5.2 How to Use the Localization Crosshair Device

- 1. The crosshair device rotates to the left or right of the tubehead. Rotate the device away from the x-ray beam during the exposure acquired with the localization paddle.
- 2. When you rotate the device back to the front for use, make sure the rotation continues until the device clicks into position.
- 3. Turn on the light field lamp.
- 4. Rotate the two crosshair knobs until the shadow on the breast matches the crosshairs on the image that identifies the suspect lesion.

7.5.3 How to Install and Remove the Magnification Crosshair Device




Figure 81: How to Install and Remove the Magnification Crosshair Device

To Install the Magnification Crosshair Device:

- 1. Remove the face shield (refer to *How to Install and Remove the Conventional Face Shield* on page 116).
- 2. Align the Magnification Crosshair Device with the tubehead.
- 3. Slide the crosshair device on the rails on each side of the tubehead that are used by the Conventional Face Shield. Make sure the device locks into position.
- 4. Install the remaining magnification devices.

To Remove the Magnification Crosshair Device:

- 1. Hold the sides of the device.
- 2. Pull the device toward you and remove from the tubehead.

7.5.4 How to Align the Crosshair Device

Note

If the crosshair light rectangle appears skewed to the opening in the paddle, perform this alignment procedure.

- 1. Install the rectangular localization paddle.
- 2. Loosen the adjustment lock screw on the bottom of the Crosshair Device.
- 3. Put a piece of white paper on the image receptor to make the shadows of the crosshairs easier to see.
- 4. Move the localization paddle approximately 6 cm above the image receptor.
- 5. Turn on the light field.
- 6. Rotate the Crosshair Device until the rectangle of light aligns with the opening in the localization paddle.
- 7. Tighten the adjustment screw.

7.6 MammoPad Breast Cushion Application Instructions

MammoPad[®] breast cushions are single-use disposable medical products. They are radiolucent and latex free. Use a fresh pad for each patient. Follow this procedure to make sure the pad is properly installed.

1. Open the bag containing the MammoPad breast cushions, remove one pad, and reseal the bag.



Note

Pads must be stored in a sealed plastic bag to prevent contamination that could affect image quality. Store out of direct sunlight and seal bag when not in use.

2. Peel the paper backing from the pad and discard it.

3. Apply the adhesive side to the breast platform in accordance with the instructions in the following note for your type of system. Do not apply the pad over painted decals.



Note

Selenia[®] and most other FFDM systems - Orient the rounded corner at the lower left side of the detector. Smooth the pad on from the back to the front of the breast platform.

Dimensions[®] and GE systems - Orient the rounded corner at the lower right side of the detector. Smooth the pad on from the front to the back of the breast platform.




Figure 82: MammoPad Installed on Breast Platform

- 4. Follow your normal positioning routine for all screening views.
- 5. When the exam is complete, remove the pad from the image platform and discard it.
 - a. Grip one corner of the MammoPad and carefully pull upward and diagonally backward from the breast platform.

If the pad was exposed to blood or body fluids, follow the biohazard materials disposal procedure for your facility.

Chapter 8 Clinical Procedures

Warning:

This device is intended to be fastened to the floor. Operating the system without correctly fastening to the floor may allow an overbalance situation resulting in injury or death.



Warning:

C-arm movement is motorized.



Warning:

Keep the hands of the patient away from all buttons and switches at all times.



Warning:

Place each footswitch in a position where, when used, they remain in reach of the Emergency Off Switches.

In the event of an emergency situation, any of the Emergency Power Off buttons can be used to immediately remove power and stop equipment motion.



Warning:

Before initiating any motion of the compression-arm or tube-arm, make sure the motion path is clear of all persons and obstructions.



Warning:

Position the footswitches to prevent accidental operation by a patient or wheelchair.

8.1 Standard Workflow

8.1.1 Preparation

- 1. Select a patient from the worklist, or manually add a new patient.
- 2. Identify the required procedures.
- 3. Select the output device set if a different or additional device is needed.
- 4. Install the paddle.
- 5. Select the first view.

8.1.2 At the Gantry

- 1. Set C-arm height and rotation angle.
- 2. Make sure the light field illuminates the correct area.
- 3. Position the patient and compress the breast.

8.1.3 At the Acquisition Workstation

- 1. Set the exposure technique.
- 2. Acquire the image.
- 3. Release the patient.
- 4. Preview the image. Look at the Exposure Index to make sure that the exposure is within acceptable range.
- 5. You can use the Window/Level tool or other image review options during image preview.
- 6. Accept, Reject, or Pend the image.
- 7. Perform the Acquisition cycle as required for the requested procedures.
- 8. If necessary, add an additional view or procedure.
- 9. Make sure that the patient is safely away from the system after you complete the examination.
- 10. Close the procedure.

8.2 Screening Procedure Example




Figure 85: Example of a Screening Procedure Screen

8.2.1 **Position the Patient**

- 1. Lift or lower the breast platform for the patient.
- 2. Move the tubehead to the projection angle.
- 3. Move the patient to the C-arm.
- 4. Position the patient as required.
- 5. Put the arm or hand of the patient on the Patient Handle or against the side of the body.
- 6. Tell the patient to keep away from system controls.
- 7. Compress the breast.
 - When possible, use the footswitch controls to provide hands-free compression control and C-arm height adjustment.
 - Use the light field lamp as necessary to see the x-ray field.
 - Apply compression slowly. As necessary, stop and make the adjustments to patient position.
 - Use the handwheels for final compression.

8.2.2 Set the Exposure Techniques

Select the exposure techniques for the procedure. Refer to <u>*How to Set the Exposure</u>* <u>*Parameters*</u> on page 90 for information.</u>

8.2.3 Acquire the Exposure

- 1. Confirm that all exposure factors are set correctly.
- 2. If the system does not display Ready in 30 seconds, verify that the accessories are correctly installed and the paddle is locked into position. When the generator status displays **Ready**, the system is ready for exposure.



Warning:

This system can be dangerous to the patient and the user. Always follow the safety precautions for x-ray exposures.

- 3. Press and hold the **x-ray** button and/or the **x-ray footswitch** for the full exposure. During the exposure:
 - A System Message with the radiation symbol and a yellow background is displayed (see the following figure)
 - An audible tone continues to sound during the exposure

The behavior of the audible tone during a combo exposure has changed to avoid early releases of the x-ray button and/or the x-ray footswitch by users. The audible tone is now a continuous sequence of tones. The tone sounds during the entire combo acquisition from the initiation of the exposure to the end of the conventional view. There is no interruption of the audible tone between breast tomosynthesis and conventional digital mammography exposures. Do not release the exposure switch during the audible tone.

4. When the tone stops and the System Message shows **Standby** (see the following figure), you can release the **x-ray** button and/or the **x-ray footswitch**.

5. Release the compression device. If the automatic release feature is set, the compression device automatically lifts after the exposure.

8.3 **Procedure for Needle Localization with Tomosynthesis**

- 1. Install a Localization Paddle, and install the Crosshair Device at the Tubehead. Be sure that the crosshair guides are out of the x-ray field.
- 2. Open a new procedure with a Tomo or TomoHD view for your approach.
- 3. Position the patient and apply compression.
- 4. Acquire a Tomo Scout. Make sure that the ROI is visible inside the Localization Paddle opening. If not, reposition the patient and repeat.
- 5. Note the Compression Thickness, and note the thickness of the excess tissue through the opening of the Localization Paddle.
- 6. Scroll through the reconstruction slices to identify where the lesion is best seen. Note the slice number (each slice is 1 mm in thickness).
- 7. Place the Acquisition Workstation crosshair on the lesion.
- 8. To find the coordinates for the Gantry Crosshair Device, scroll through the reconstructions until you can identify the alpha numeric coordinates.
- 9. Calculate the needle depth:

Value	Example
Breast Compression Thickness	50 mm
(+) Thickness of the tissue through the opening of the paddle	+ 7 mm
(-) Slice number where the lesion is found	- 30 mm
(+) Optional distance past the ROI for the wire	+ 5-15 mm
(=) Needle depth of the localization wire	32– 42 mm

- 10. Turn on the collimator light and align the Crosshair Device at the Tubehead to match the Acquisition Workstation crosshair.
- 11. Position and insert the needle.
- 12. Move the Crosshair Device guides out of the x-ray field.
- 13. Acquire another Tomo image to be sure that the needle is in the correct location. To calculate if a correction is necessary, compare the slice number of the point of the needle and the slice number of the lesion.
- 14. Insert the guide wire through the needle, then remove the needle, if desired, leaving the wire in position.
- 15. If desired, complete the following steps:
 - a. Acquire a Conventional or Tomo view to be sure of correct wire placement.
 - b. Take the orthogonal view to document wire or needle placement (either in Tomo or conventional).
- 16. Only add one view icon at a time for orthogonal views to remove the possibility of paddle shift due to possible minimal compression.

Example: Calculating Needle Depth with Tomosynthesis

In this example, use the values from the table on the previous page and see the following figure.

Calculate the needle depth from the tissue skin line (item 1) rather than from the localization paddle (item 9). Insert the needle a minimum of 27 mm (breast compression + bulging tissue).




Figure 88: Calculating needle depth

Chapter 9 Maintenance and Cleaning

9.1 Cleaning

9.1.1 General Information About Cleaning

Before each examination, clean and use a disinfectant on any part of the system which touches a patient. Give the attention to the paddles and the image receptor.



Caution:

Do not use any hot source (like a heating pad) on the image receptor.

Be careful with the compression paddles. Inspect the paddles. Replace the paddles when you see damage.

9.1.2 For General Cleaning

Use a lint-free cloth or pad and apply a diluted dishwashing liquid.



Caution: Use the least possible amount of cleaning fluids. The fluids must not flow or run.

If more than soap and water is required, Hologic recommends any one of the following:

- 10% chlorine bleach solution and water with one part commercially available chlorine bleach solution (normally 5.25% chlorine and 94.75% water) and nine parts water. Mix this solution daily for best results.
- Commercially available isopropyl alcohol solution (70% isopropyl alcohol by volume, not diluted)
- 3% maximum concentration of hydrogen peroxide solution

After you apply any of the above solutions, use a pad and apply a diluted dishwashing liquid to clean any parts that touch the patient.



Warning:

If a paddle touches possible infectious materials, contact your Infection Control Representative to remove contamination from the paddle.



Caution:

To prevent damage to the electronic components, do not use disinfectant sprays on the system.

9.1.3 To Prevent Possible Injury or Equipment Damage

Do not use a corrosive solvent, abrasive detergent, or polish. Select a cleaning/disinfecting agent that does not damage the plastics, aluminum, or carbon fiber.

Do not use strong detergents, abrasive cleaners, high alcohol concentration, or methanol at any concentration.

Do not expose equipment parts to steam or high temperature sterilization.

Do not let liquids enter the internal parts of the equipment. Do not apply cleaning sprays or liquids to the equipment. Always use a clean cloth and apply the spray or liquid to the cloth. If liquid enters the system, disconnect the electrical supply and examine the system before returning it to use.



Caution:

Wrong cleaning methods can damage the equipment, decrease imaging performance, or increase the risk of electric shock.

If liquid is spilled on the system, turn the system off immediately. Do not turn the system on until the liquid has dried completely. Do not splash or spray cleaning solution on the system.

Always follow instructions from the manufacturer of the product you use for cleaning. The instructions include the directions and precautions for the application and contact time, storage, wash requirements, protective clothing, shelf life, and disposal. Follow the instructions and use the product in the safest and most effective method.

9.1.4 Acquisition Workstation

How to Clean the Image Display Screen

Avoid touching the display screen of the Image Display monitor.

Use care when cleaning the outer surface of the LCD screen. Always use a clean, soft, lint-free cloth to clean the display area. Microfiber cloths are recommended.

- Never use a spray or flow a liquid on the display.
- Never apply any pressure to the display area.
- Never use a detergent with fluorides, ammonia, alcohol, or abrasives.
- Never use any bleach.
- Never use any steel wool.
- Never use a sponge with abrasives.

There are many commercially available products to clean LCD displays. Any of the products free of the listed ingredients and used according to the directions of the manufacturer can be used.

How to Clean the Touchscreen Display

Use a window or glass cleaning product to clean the Touchscreen display. Apply the cleaning product to a cloth, then clean the Touchscreen display. Do not apply the cleaning product to the display without the cloth.

How to Clean the Keyboard

Wipe the surfaces with a CRT wipe. If necessary, clean the keyboard with a vacuum. If liquids enter the keyboard, contact Technical Support for a replacement.

How to Clean the Fingerprint Scanner



Caution:

To protect the Fingerprint Scanner:

- Do not apply any liquid product directly on the Fingerprint Scanner window.
- Do not use products that contain alcohol.
- Never put the Fingerprint Scanner under liquid.
- Never apply any pressure to the Fingerprint Scanner window with abrasive material.
- Do not push the Fingerprint Scanner window.

To clean the Fingerprint Scanner window, do one of the following:

- Apply the adhesive side of cellophane tape, then remove the tape.
- Apply a product with ammonia base to a cloth and clean the Fingerprint Scanner window.




Figure 89: Admin Screen




Figure 96: Height Adjust Control Panel




Figure 98: Preferences Button in the Admin Screen




Figure 99: Console Tab of the System Preferences Screen




Figure 100: Height Adjust Control Panel




Figure 103: I-View 2D Contrast Default Settings




Figure 106: User Selection for Genius AI Detection Software Case Processing




Figure 110: System Tools Welcome Screen




Figure 113: Archive Button




Figure 116: Tubestand (Gantry with C-arm) Measurements




Figure 117: Universal Acquisition Workstation Measurements




Figure 118: Premium Acquisition Workstation Measurements





Figure 119: Standard Acquisition Workstation Measurements




Figure 121: Mobile Premium Acquisition Workstation Measurements

Some conditions require a system restart or indicate that more action is necessary (for example, to call Hologic Technical Support). This appendix describes the message categories and your actions to return the system to normal operation. If errors repeat, contact Hologic Technical Support.

B.2 Types of Messages

B.2.1 Fault Levels

Each Message has a particular set of the following characteristics:

- Aborts an exposure in progress (yes/no)
- Prevents an exposure from starting (yes/no)
- Displays a message to the user on the Acquisition Workstation (yes/no)
- May be reset by the user (yes/no)
- May be reset automatically by the system (yes/no)

Displayed Messages

All displayed messages will be shown in the user's selected language.

Any message which aborts an exposure or prevents an exposure from starting will always display a message directing the user's actions required to proceed.

Additional Message Information

Technical information about the message is available in the log file.

Some messages always show as a critical fault (a system restart is necessary). These messages result from a condition which prevents an exposure, and which cannot be reset by the user or the system.




Figure 122: UPS LCD Display

Appendix C Use of Mobile System

This appendix describes the system installed in a mobile environment.

C.1 Conditions for Safety and Other Precautions

An acceptable, stable, clean VAC power source is required to make sure that the system meets all its performance specifications. Where available, shore power correctly supplied to the system provides the best performance. If a mobile power generator is used, you must keep the specifications for input power during all load conditions.



Warning:

The radiation shield is not approved for mobile use and is not provided. The coach manufacturer must provide adequate shielding.



Caution:

When shore power is unavailable, mobile power sources that provide equivalent performance may be employed. (Refer to <u>Specifications for Mobile Use</u> on page 182.) Proper system function and performance can only be ensured if continuous true sinusoidal VAC power is supplied per the system power input specifications and loading characteristics. Intermittently, the power source must provide 65 Amps at 208 VAC for a minimum of 5 seconds, and 4 Amps maximum continuous otherwise. This load must be supported once every 30 seconds. In the event of shore or mobile power service interruption, the UPS must be capable of providing the operational power described above for a minimum of 4 minutes. Acquisition Workstation and Gantry power must be fed on separate dedicated circuits. The use of an uninterruptible power supply with active line conditioner is recommended on each power circuit. Accordingly, all ancillary mobile coach power should be distributed by other circuits. The electrical installation must be verified to meet system power input specifications and IEC 60601-1 safety requirements after initial installation and upon each relocation of the mobile coach.



Caution:

The temperature and humidity inside the vehicle must be maintained at all times. Do not allow environmental conditions to exceed stated specifications when the unit is not in use.



Caution:

Voltages cannot change by more than ±10% when the x-ray unit or other equipment (for example, heating or air conditioning) is operated.

Caution



To avoid image artifacts from occurring:

- Care should be exercised not to locate or park the mobile coach near sources of high power (such as power transmission lines and outdoor transformers).
- Make sure that any mobile power generator, uninterruptible power system (UPS), or voltage stabilizer is at least 3 meters (10 feet) from the closest point of the image detector travel.
- Damage to the breast platform or paddles may cause artifacts within the image.




Figure 123: Keyboard Tray Lock Knob, Right <u>or</u> Left Side (Universal Acquisition Workstation)




Figure 124: Keyboard Tray Lock Knob (Premium Workstation)




Figure 125: Tray Lock Release from Locked (A) to Unlocked (D)




Figure 126: Swivel Monitor Lock Knobs on the Mobile Universal Acquisition Workstation (series I)




Figure 127: Swivel Monitor Lock Knobs on the Mobile Universal Acquisition Workstation (series II)




Figure 128: Tray Lock Release from Locked (A) to Unlocked (D)




Figure 129: Swivel Monitor Lock Knobs on the Mobile Universal Acquisition Workstation (series I)




Figure 130: Swivel Monitor Lock Knobs on the Mobile Universal Acquisition Workstation (series II)
